Why you should work for CSCL:

What you’ll do as the Community Living Support Worker:

- Provide support to individuals with varied abilities within a day program setting
- Perform safe transferring techniques and participate in all aspects of recreation and leisure activities (e.g. swimming), including transportation of supported individuals
- Promote and support Individual rights and facilitate meaningful community inclusion
- Facilitate ongoing learning opportunities for personal growth and development of the individual
- Facilitate opportunities for the development of personal relationships
- Communicate with families and caregivers
- Contribute to the development and implementation of monthly activity schedules
- Promote Positive Behaviour Supports and effective communication

Qualifications:

- Experience, education and/or training in supporting individuals with developmental disabilities (particularly individuals with high medical needs)
- Experience supporting individuals with high risk behaviors as well as a working knowledge of Mental Health Disorders and positive practices for managing challenging behavior
- A positive and pleasant work attitude, effective communication skills and the ability to relate positively to the public
- Able to work independently while maintaining one’s responsibility to a larger team
- Must be flexible, with a willingness to take on new tasks while working in a variety of settings and to accommodate the needs of individuals without prejudice or influence
- Must be physically able to perform all lifting/transferring duties and participate in regular program activities (i.e. swimming)
- Must possess a valid BC Class 4 Driver’s License and be willing to obtain First Aid/CPR Certification



Schedule:

Monday to Friday 9am-3pm but will also work some 2-8pm shifts and an occasional Saturday 2-8 shift to suit service needs. Thus schedule flexibility is required for all day, afternoon and weekend shifts.

This is a "float" style position to cover shorts from vacation and leave requests. This position is guaranteed a minimum of 30 hours per week, posted 2 weeks ahead as per collective.

This position presents the possibility of working up to 40 hours per week at straight-time (The hours in this position may be worked over a 7-day work week consistent with Article 14.1 – Definitions)
